Location

The land lies in the Open Countryside, fronting Grasby Road between North Kelsey Moor and Grasby. The market town of Caistor is situated just 4 miles to the East and Brigg is 7.50 miles North West.

General Description

A small compartment of amenity land in an arable rotation most recently used for growing root vegetables for private use and consumption. It could easily be grassed down, planted to trees or put to environmental use.

The Land is classified Grade III by the MAFF land classification maps for the region. The Soil Survey of England and Wales describe the land as being of the Blackwood Association, comprising deep, permeable, course sandy and loamy soils. Groundwater controlled by ditches. it is considered suitable for cereals, potatoes, sugar beet and grassland as well as coniferous woodland use.

It is of a regular shape and flat in nature. The access is via a Right of Way over third party land.

Boundaries

The land is Freehold. Vacant Possession will be granted on completion.
